14G Dates for Extracts: For the start dates for these reports you will want to use your first day of school last year and for the end date you will want to use the day after your last summer grad or one day before your first day of school this year.

Example: 08/xx/2013 to 08/xx/2014

14G Record types:

- GI – Student Demographics
- FN – Student Attributes – No Date
- FA – Student Assessment (**including AC, AP, IB, and SA assessment records**)
- FE – Student Special Education Graduation Requirement
- GP – Graduation Only
- GC – Student Graduation CORE Summary

PowerSchool Users

You should have already completed your mass updating of diploma dates and types and so on from our yearend processes months ago and have already taken care of any retained students. You will need to Un-check the Exclude From State Reporting? Check box from Graduate building for G reporting. The PS path is **District>District>Schools/School Info**

NOTE: If S,R,C or N reporting periods are open at the same time – remember to then re-check this so as to not include the information from the Graduate building when running your other extracts.

What's New for 14G?

Reporting of the dual credit earned field for the GC – Student Graduation CORE Summary report.

PowerSchool users will find this field on the Course record and Student's Historical grades records. The below information is from the PowerSchool state update release notes:

Course Update:

Description: The State has added the collection of *Dual Enrollment Credit Earned* for students who are taking courses that earn credit for both high school and college transcripts.

Resolution: The Courses page, *Start Page > School Setup > Courses > Edit Course District Information*, is updated allowing users to enter the potential semester hours a student is earning, *Dual Credit*, on the college transcript for the course.

Historical Grades Update:

Description: The State has added the collection of *Dual Enrollment Credit Earned* for students who are taking courses that earn credit for both high school and college transcripts. Users also need a methodology for students transferring from another school district who have their courses hand entered and need to capture the dual enrollment credit as necessary. Also this will provide a means for users to enter this information on past courses or to override the potential credit value on the course record.

Resolution: The Historical Grades page, *Start Page > Student Selection > Historical Grades > Edit Stored Grade*, is updated allowing users to enter the semester hours earned, *Dual Enrollment Credit Earned*, for a course.

Please note that if you adjust this value on your courses, it should use this value when the GC report extracts your student's historical grades data. If however you did not have these courses set up in PS, but manually entered this data into historical grades for students when they completed this course, you will need to manually adjust these individual historical grades for those students.

PowerSchool quick note on Summer Graduates: Those summer graduates should be in your current building (not the graduated building). If they graduated during the summer, they will have a current transfer info record for the 14/15 school year, then they can be withdrawn with the appropriate code for a graduate and then their EMIS screens can also be updated to reflect their grad date and diploma type and so on needed for 14G reporting. The reason they are in the current building is you'll need to get the withdraw reported this fall or they could be end up being a missing student. Remember, if they did not graduate over the summer, they should be then withdrawn with the most appropriate 7X withdraw reason during this fall EMIS reporting and adjust the FN grade level next year to DR.
